- Participants will be able to identify how to give informed consent and receive the signed consent documents with the young woman in case study three (including the discussion of how one can reasonably confirm the person is who she says she is when not able to make visual contact with the client).
- Participants will be able to describe how to bring a systemic perspective to this digital therapy case with an individual.
- Participants will be able to describe how teletherapy theory applies to all three cases.
- Participants will be able to identify how KRS 335.380 (enacted in July 2000) applies to all three cases
- Participants will be able to describe HIPAA considerations with all three cases.

This workshop offers specific, realistic examples of the challenges and benefits of implementing technological assistance into therapeutic practice.

Course Outline

1. The Hernandez family: Serving a family in a rural setting without reliable transportation and no home internet service.
2. The Ramirez family: Avoiding abandonment when clients move to an area with no nearby therapists.
3. Angie: Therapy with someone who would rather use texting than online streaming as a therapeutic platform.
